**Nuwe lede**

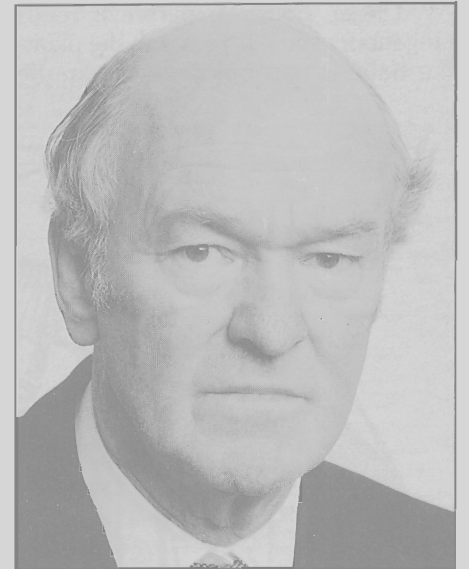
