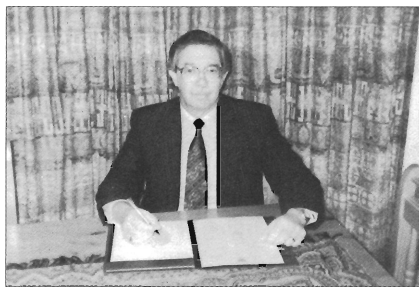
## Johannesburg

### *Nuwe Adjunk-regter-president*

### *Appointment to Bench*

### *Huisvesting*

Die "nuwe gebou spook" is nog met ons. Aan die begin van 1987 het die Balie na baie traumatiese vergaderings en debatvoering vanaf die ou Nederlandse Bankgebou verhuis na die nuwe Momentumsentrum. Die paar bittereinders wat agtergebly het in die Standard Bankkamers op die Plein het ook later ingewillig om aan die begin van 1992 by die meerderheid aan te sluit.

Nou is daar weer sterk sprake van die moontlikheid dat die Balie 'n nuwe gebou nader aan die Hooggeregshof sal betrek en minstens drie projekte word tans oorweeg. 'n Spesiale Algemene Vergadering om hieroor te besin is belê vir 18 Augustus.

Talking about the Supreme Court, it has now been authoritatively learned that the new Supreme Court building project (the extensions behind the existing Palace of Justice) which had been temporarily halted will proceed and that target date for completion is some time in 1992.

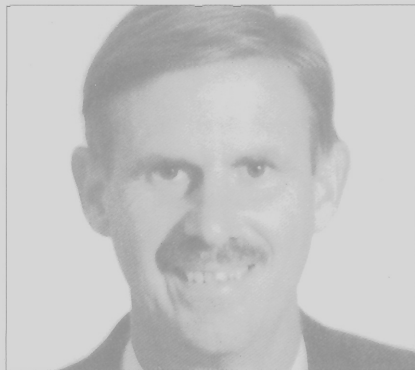
### *Aanstelling van kantoorbestuurder*
