The Bench

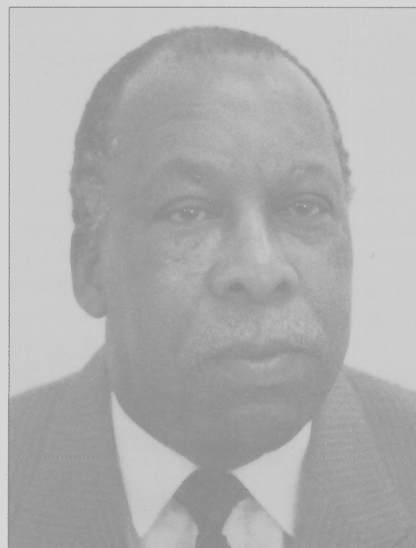
Hancke J left this Division at the end of January 1993 to return to the Orange Free State Provincial Division.
