The first edition of *Hockly's Insolvency Law* was published in 1940. Throughout the years the book established itself as a basic text for students, and a guide or easy source of reference to insolvency practitioners. This edition contains new chapters on creditor's claims and their ranking, insolvent deceased estates, the winding-up of companies, the winding-up of close corporations, and judicial management. The appendices have been expanded to include specimen estate accounts and liquidation applications. The authors, however, decided not to include any discussion on the new sections introduced by the Insolvency Amendment Act 32 of 1995 relating to transactions in financial markets.
