


Continuing Legal Education

Late last year a small group of members practising from 42 Keerom Street got together to initiate a Continuing Legal Education (CLE) programme at the Cape Bar. The CLE programme, which enjoys the full endorsement of both the Bar Council and Advocates for Transformation, is aimed at practitioners generally, and those of 0 to 3 years' standing in particular. The primary objective of the programme is to bridge the often wide gap between pupillage and practice by attempting to develop the skills and knowledge of members even further in essential areas of practice such as Third Division, urgent applications, insolvency, criminal practice, civil trials, cross-examination, legal drafting, opinions and legal argument.

The programme will initially take the form of monthly seminars held in the common room, which will be conducted by members of the Bench and of the Bar. As such the programme will hopefully serve the purpose of not only further educating, training and building confidence in new members appearing in court for the first time, but also in introducing new members to judges and to their more senior colleagues. In the three well-attended seminars which have been held to date, Selikowitz and Davis JJ, and Ntsebeza AJ, have presented the topics "Banishing the Third Division Blues", "Oral and Written Argument" and "Amnesty and Constitutionalism – an Oxy-moronic Concept?"

CLE is, at present, operated on an *ad hoc* basis by Peter Volmink, Vuyani Ngalwana, André Botha and Nazreen Bawa. It is hoped that in due course CLE will become a fixed policy of a new Bar Council which will hopefully have a permanent CLE sub-committee to ensure the continued operation of this vital service to members.

New Minister of Justice and Constitutional Development

Penuell Mpapa Maduna, formerly Minister of Mineral and Energy Affairs, has been appointed as Minister of Justice and Constitutional Development, succeeding Mr Dullah Omar, who has been appointed as Minister of Transport in President Thabo Mbeki's new cabinet.

Born on 29 December 1952. B Juris UNISA LLB Zimbabwe; Higher Diploma in Tax Law LLM Witwatersrand; LLD UNISA. Admitted as an attorney, notary and conveyancer of the Transvaal Provincial Division of the High Court. Involved in politics since his student days; was a member of the SRC of the University of Zululand; worked in underground structures of the ANC; prosecuted twice in the 1970s; went into political exile in 1980.

Held various appointments in ANC structures, including that of legal adviser at the ANC headquarters and member of its Department of Legal Constitutional Affairs. Participated in virtually all the meetings the ANC had with "White South Africa" from the mid 1980s. Was one of the first two ANC officials sent in March 1990 to launch the process of "talks-about-talks" that led to the negotiated political transition, and was part of the ANC teams that were involved in the various processes and crises that led to the adoption of the interim constitution.

A keen "participant in the affairs of soccer", a former amateur boxer and, in his own words "loves reading classics and novels, and loves debates and debating".
