It is with a deep sense of sadness that the Port Elizabeth Bar says goodbye to one of its favourite members and indeed, at the time of his retirement, the most senior practising junior advocate in the country.

Johan Adriaan Frederik (Fred) Nel was born on 18 June 1920 in the Eastern Cape. He had a varied and spirited career. He was admitted as an advocate in 1951 and took up chambers in Port Elizabeth in that same year. He, however, dabbled in teaching, was a member of

parliament (at the youthful age of 33) and was the clerk of the late Judge Oscar Hoexter. He practised at both the Cape Town and Johannesburg Bars before returning to Port Elizabeth in 1978. Until the date of his retirement Fred remained a popular, if not an automatic, choice of the judges when it came to the selection of assessors in criminal trials.

Younger members of the Bar were amazed at how the blue flame of youth still burned brightly in Fred's eyes when nearing the end of his long career. I recall the occasion of Fred's 80th birthday, celebrated in the common room, and the way in which he regaled his audience with stories in the manner of a seasoned raconteur.

Having spoken to a number of the more senior members in our Bar, I settled on the following quote from De Bruyn SC:

"Fred was baie gesondheidsbewus, en het op die ouderdom van 75 jaar nog lidmaatskap by die Health & Racquet Klub vir 'n tydperk van tien jaar hernieu.

Fred is 'n plat-op-die-aarde mens, en sy wonderlike sin vir humor, sy hulpvaardigheid teenoor sy kollegas, en sy onkreukbare eerlikheid sal baie deur sy kollegas gemis word."

No doubt Fred will be fondly remembered by all who knew him.

Gewese regter-president JJ Kriek

Regter JJ Kriek (72) is op 24 Mei 2002 oorlede. Tydens 'n huldeblyk in die hooggeregshof in Kimberley het verskeie oud-kollegas gewys op sy besondere intellek, sy vermoë om as regter onmiddellik die kern van 'n saak raak te sien, asook sy goeie menseverhoudinge.

Teenwoordig by die geleentheid was die president van die Hoogste Hof van Appèl, regter Joos Hefer, twee voormalige regter-presidents, regters Ernst Lichtenberg (OVS) en Appie Steenkamp (Noord-Kaap), asook die huidige regter-president van die Oranje-Vrystaatse Provinsiale Afdeling van die Hooggeregshof, regter Koos Malherbe.

Regter Kriek is gebore op 1 Desember 1930 in Bethlehem. Hy matriculeer aan die Hoërskool Greytown Hy is op 42-jarige ouderdom as regter en op 1 Junie 1990 as regter-president van die Noord-Kaapse afdeling van die Hooggeregshof aangestel. Hy het op 1 Desember 1999 afgetree.
