At a resoundingly successful launch of ProBono.Org at Constitution Hill, Johannesburg, on 7 May 2007, a spectrum of South African and American legal practitioners discussed optimum ways to do pro bono work for maximum impact.

ProBono.Org is the first initiative of its kind in South Africa. The organisation is mandated to provide a matching service linking the poor and the vulnerable, who cannot access justice due to prohibitive costs, to the legal profession willing to render pro bono legal services.
