### Appointment as SCA judge

Judge Suretta Snyders, a former member of the Johannesburg Bar, has been appointed as a judge of the Supreme Court of Appeal from 1 December 2008.

Suretta Snyders was raised in Prieska, Northern Cape. The closest town was Kimberley where Judge Leo van den Heever was a judge. This was an inspiration to Judge Snyders who had a desire to become an advocate at the Johannesburg Bar from an early age and saw Judge van den Heever as a role model for her own future.

Upon obtaining her university exemption she studied at the University of Stellenbosch where she obtained the degrees BComm (Law) in 1980 and LLB in 1982. She was the head of her house in her final year.

Because Judge Snyders funded her studies with a bursary from the Department of Transport, she started her career in its legal department. During the middle of 1984, Judge Snyders commenced her pupillage and became a member of the Johannesburg Bar at the end of 1984. She practised as a member of Group 444 and was conferred silk in November 1996. She took acting appointments in Johannesburg during 1996 and was permanently appointed to the Johannesburg Bench on 1 February 1997. For six months in 2007 and 2008 she took acting appointments in the Supreme Court of Appeal. Having now been permanently appointed

to the Supreme Court of Appeal from the beginning of 2009, she sees herself slowly returning to her roots in the Karoo, not far off from Bloemfontein.

Judge Snyders sadly lost her husband, Robert in 2001. Her son, Martin, currently lives in Johannesburg.

Judge Snyders is an outdoor person who loves nature and often returns to Prieska. She has climbed the live Volcano in the Atacam Desert in Chile, she has snorkelled in the Galapagos, she went canopy gliding in the woods of the Andes Mountains, she rowed on the Okavango, went climbing in the Tsingi in Madagascar and she goes white water river rafting whenever the opportunity arises - in short the more adrenalin, the better. We wish Judge Snyders well in her new and esteemed position.
